**CONTRACT RULES:**

Set up is Sunday, September 16th from 7:00 to 9:00 AM. Dealers must be set up by 9:00 AM. Only those identified by name on the dealer contract will be allowed admission during setup hours. A maximum of two persons will be allowed per dealer contract. Sub-leasing of tables is prohibited.

Dealers will not pack or leave prior to 2:00 PM. Strict adherence to this rule is expected.

GBBCA will guarantee no refund of acknowledged reservations. We will make every effort to fill a canceled reservation and if successful, a refund will be made less any expense incurred.

GBBCA reserves the right to determine eligibility of any dealer or items offered for sale, including collectibles. Acceptable items include bottles, fruit jars, insulators, stoneware, advertising, breweriana, collectibles, postcards, books and antiques. All items must be visibly priced by the opening of the show. Any defective, repaired or reproduction items must be so marked.

Tabletop racks will be allowed, but within the confines of the rented table, either above or directly below the table. Audio and/or visual effects, furniture or extra tables will not be permitted. Dealers must supply their own table covers.

Dealers agree to hold harmless the GBBCA, its members and the Polish Falcons from loss of or damage to dealers' property by theft and/or accidental causes. Dealers understand that they will be fully responsible for the protection of their property while at the show location and that the GBBCA, its members and the Polish Falcons will not be responsible for loss or damage to dealers' property.

Only those wearing name badges will be given access to the building during setup.

Turn right onto Transit Road/NY-78- 1.9 miles.

Turn left onto French Road- .2 mile.

French Road becomes Columbia Avenue.

West of Buffalo on the New York State Thruway/I-90:

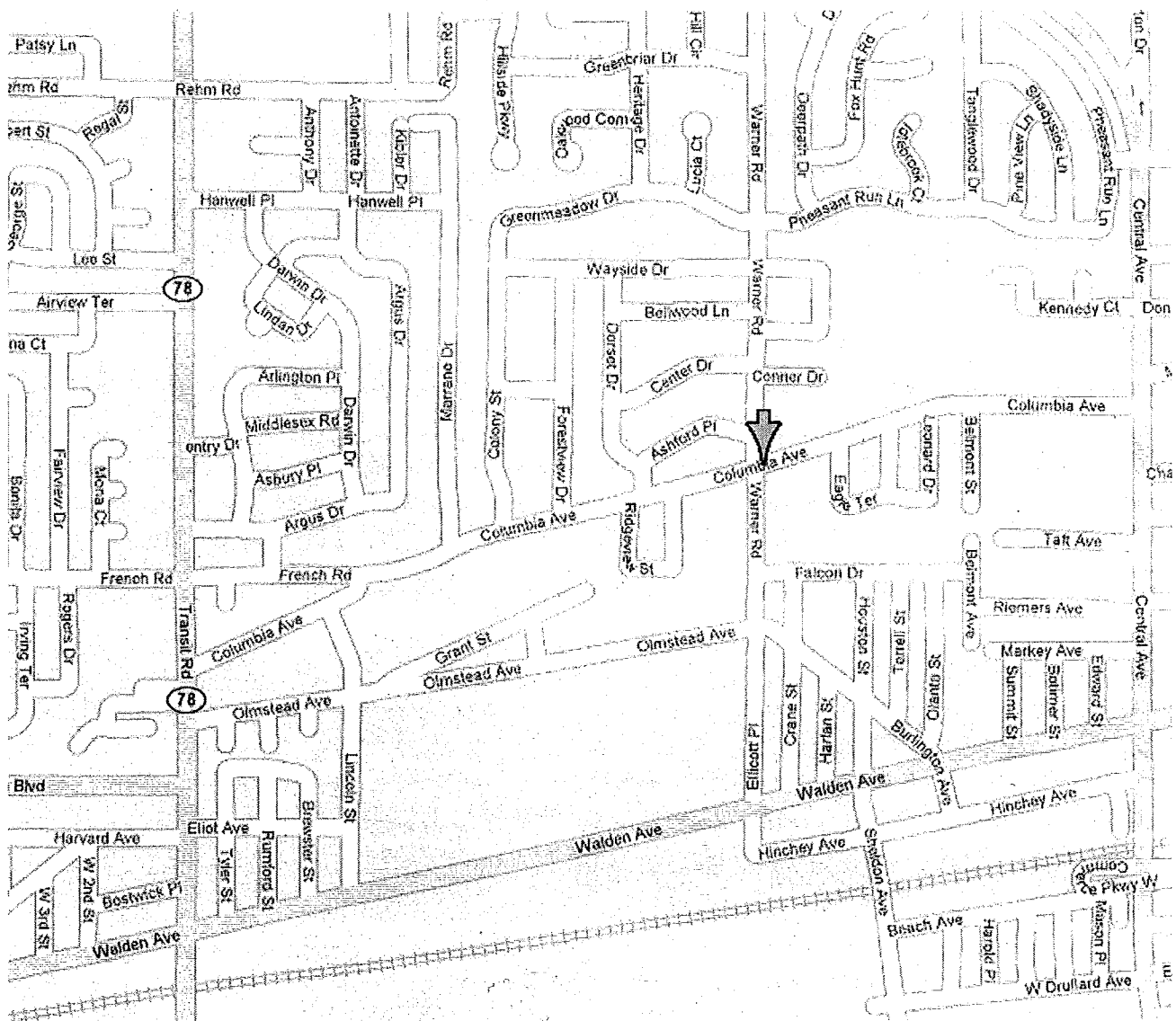
Take the Walden Avenue East exit/EXIT 52E-toward Cheektowaga- .3 mile.

Turn left onto Ellicott Place- .2 mile.
